# Michael Bodaken

#### PROFESSIONAL SUMMARY

For the past 20 years, Michael Bodaken has served as the President of the National Housing Trust. The Trust engages in preservation policy, affordable housing development and lending. He has been responsible for growing the organization in becoming a nationwide leader in the field of affordable housing preservation policy and practice. The Trust urges state and federal governments to devote sufficient resources to save existing housing, with a particular emphasis on preserving housing in "communities of opportunity," where poor residents have a better chance to reach their potential. The Trust also promotes "Green Preservation," involving the energy retrofitting of existing housing and saving affordable housing proximate and accessible to mass transit.

Mr. Bodaken also serves as President of NHT/Enterprise, an organization founded by the Trust which owns and operates 3,400 affordable apartments in nine states and the District of Columbia. The Trust's U.S. Treasury Certified Development Financial Institution, the NHT Community Development Fund, provides low interest loans to preservation developers across the U.S. During his tenure, the Trust has financed and preserved over 20,000 apartments throughout the nation, involving over \$1 billion in financing.

Prior to joining the Trust, Mr. Bodaken worked as Deputy Mayor for Housing for the City of Los Angeles. Before joining the City of L.A., Mr. Bodaken practiced public interest law for over a decade, specializing in class action homeless litigation, tenants' rights and affordable housing policy.

Mr. Bodaken is the convener of the National Preservation Working Group, a member of the Advisory Board of the Housing Development Reporter and the Board of Governors of the National Housing Conference. He serves on the board of directors of Homes for America, Housing Justice Center, the Montgomery County Housing Tax Force, and Stewards for Affordable Housing (SAHF). He is a frequent guest lecturer and panelist at affordable housing industry events and Congress. He has guest lectured on affordable housing policy and sustainability at the University of Maryland and University of Virginia.
